



## Newly Diagnosed HIV Cases in the Philippines


**Figure 1. Number of New HIV Cases per Month (2009-2011)**

In September 2011, there were 253 new HIV Ab sero-positive individuals confirmed by the STD/AIDS Cooperative Central Laboratory (SACCL) and reported to the HIV and AIDS Registry (Table 1). This was 65% higher compared to the same period last year ( $n=153$  in 2010) [Figure 1].

Most of the cases (95%) were males. The median age was 27 years (age range: 16-67 years). The 20-29 year (57%) age-group had the most number of cases. Fifty-three percent (135) of the reported cases were from the National Capital Region (NCR).

Reported mode of transmission was sexual contact (226), and needle sharing among injecting drug users (27) [Table 2, page 3]. Males having sex with other Males (83%) were the predominant type of sexual transmission [Figure 2]. Most (98%) of the cases were still asymptomatic at the time of reporting [Figure 3].

### AIDS Cases

Of the 253 HIV positive cases, five were reported as AIDS cases; all were males. The median age is 40 years (age range: 18-50 years). 80% acquired the infection through sexual contact [homosexual (3), bisexual (1)], and 20% acquired it through needle sharing among injecting drug users. Of the AIDS cases, there were two reported deaths for this month; both were males, ages 40 and 49 years old.

### Overseas Filipino Workers (OFW)


Sixteen of the 253 (6%) reported cases were OFWs [Figure 9, page 3]. There were 11 males and 5 females. The median age was 36 years (age range: 24-59 years). All cases acquired the infection through sexual contact (10 heterosexual, 1 homosexual, and 5 bisexual).



## AIDS Cases (1984-2011)

Of the 1,669 HIV positive cases in 2011, seventy-one were reported as AIDS cases. Eighty-seven percent were males. Ages ranged from 1-59 years (median 31 years). 96% (68) acquired the infection through sexual contact [heterosexual (18), homosexual (30), and bisexual contact (20)]. Other modes of transmission include: (1) mother-to-child transmission and (2) needle sharing among injecting drug users.




**Fig 4. Proportion of Modes of Transmission of AIDS Cases by Year, Jan 1984–September 2011**

From 1984 to 2011, there were 936 AIDS cases reported, 73% (679) were males. Median age was 35 years (range 1-72 years). Of the reported AIDS cases, there were 339 (36%) deaths. Sexual contact was the most common mode of HIV transmission, accounting for 93% (872) of all AIDS cases. More than half (468) of sexual transmission was through heterosexual contact, followed by homosexual contact (306) then bisexual contact (98). Other modes of transmission include: mother-to-child transmission (18), blood transfusion (10), injecting drug use (6), and needle prick injuries (2) [Figure 4]. Three percent (28) of the AIDS cases did not report mode of HIV transmission.

## Demographic Characteristics (1984-2011)


In 2011, there were a total of 1,669 cases reported. 93% of the cases reported were males (1,549). Ages ranged from 1-67 years old (median 27 years). The 20-29 year old age group (60%) had the most number of cases for 2011. For the male age group, the most number of cases were found among the 20-24 years old (27%), 25-29 years old (34%) and 30-34 years old (17%) [Figure 5].

From 1984 to 2011, there were 7,684 HIV Ab sero-positive cases reported (Table 1), of which 6,748 (88%) were asymptomatic and 936 (12%) were AIDS cases. As shown in Figure 6, there is a significant difference in the number of male and female cases reported. Eighty-one percent (6,246) were males. Ages ranged from 1-73 years (median 30 years). The age groups with the most number of cases were: 20-24 years (20%), 25-29 (26%) and 30-34 years (19%) [Figure 6].

## Modes of Transmission (1984-2011)

In 2011, 96% (1,597) were infected through sexual contact, 4% (63) through needle sharing among injecting drug users, <1% (3) through mother-to-child transmission and <1% (1) through blood transfusion; 5 had no reported data on mode of transmission (Table 2). There were 1,483 males and 114 females infected through sexual transmission. The age range of those infected through sexual transmission was 15-67 years old (median 27 years).

Of the 7,684 with HIV from 1984 to 2011, 91% (7,013) were infected through sexual contact, 3% (218) through needle sharing among injecting drug users, 1% (55) through mother-to-child transmission and <1% (20) through blood transfusion. Other modes of transmission are listed in Table 2. No data is available for 5% (375) of the cases. Cumulative data shows 40% (2,784) were infected through heterosexual contact, 37% (2,585) through homosexual contact, and 23% (1,644) through bisexual contact. From 2007 there has been a shift in the predominant trend of sexual transmission from heterosexual contact (23%) to males having sex with other males (77%) [Figure 8].

## Overseas Filipino Workers (OFW)


In 2011, there were 206 HIV positive OFWs, comprising 12% of cases reported for the year [Figure 9]. Of these, 171 (83%) were males and 35 (17%) were females; all infected through sexual contact.

There were 1,729 HIV positive OFWs since 1984, comprising 22% of all reported cases [Figure 9]. Seventy-six percent (1,317) were males. Ages ranged from 18 to 69 years (median 35 years). Sexual contact (96%) was the predominant mode of transmission (Table 3). Eighty-four percent (1,454) were asymptomatic while 16% (275) were AIDS cases.



**Figure 7. Proportion of Modes of HIV Transmission by Age-Group, 2011(n=1,669)**



## Program Related Information

Of the 253 HIV positive cases reported in September 2011, five were classified as AIDS. Seventy-five percent of the cases received information on HIV prevention, services available for HIV cases, implications of an HIV positive result from screening and confirmation. Their sources of information were one-on-one counseling, group counseling, pre-departure orientation seminar (PDOS), pamphlets, videos, internet and seminars.


## Blood Units Screened for HIV

**Note:** The following information is from the National Voluntary Blood Safety Program (NVBSP) which monitors blood safety of donated blood. HIV reactive blood units are referred to the Research Institute for Tropical Medicine (RITM) for confirmation. RITM is the National Reference Laboratory for the NVBSP.

From January to September 2011, 674 blood units were screened reactive for HIV and referred to RITM for confirmation. All these HIV reactive blood units were immediately sent to RITM and not transfused to anyone.

For September 2011, out of 48 screened HIV reactive blood units referred for confirmation, 10 units were confirmed positive for HIV by RITM, and 38 were negative for HIV [Table 4].

**Philippine HIV & AIDS Registry**

The Philippine HIV & AIDS Registry is the official record of the total number of laboratory-confirmed HIV positive individuals, AIDS cases and deaths, and HIV positive blood units in the Philippines. All individuals in the registry are confirmed by the STD/AIDS Cooperative Central Laboratory (SACCL) at San Lazaro Hospital. While all blood units are confirmed by the Research Institute for Tropical Medicine (RITM). Both are National Reference Laboratories (NRL) of the Department of Health (DOH).

Mandatory HIV testing is unlawful in the Philippines (RA 8504). The process of reporting to the Registry is as follows: All blood samples from accredited HIV testing facilities that are screened HIV reactive are sent to SACCL (individuals) or RITM (blood units) for confirmation. Confirmed HIV positive individuals and blood units are reported to the DOH-National Epidemiology Center (NEC), and are recorded in the Registry.

The Registry is a passive surveillance system. Except for HIV confirmation by the NRL, all other data submitted to the Registry are secondary and cannot be verified. An example would be an individual's reported place of residence. The Registry is unable to determine if this reported address is where the person got infected, or where the person lived after being infected, or where the person is presently living, or whether the address is valid. This limitation has major implications to data interpretation. Thus, readers are cautioned to carefully weigh the data and consider other sources of information prior to arriving at conclusions.
